

Proposed Division 5 Regulations Changes <u>Specific Changes</u>

Article III. Management

Existing Wording

2. The appointed officers of the Division shall be the Treasurer, the Clerk, the Directors, and the Trainwire Editor. The Superintendent shall appoint these officers.

New Wording

2. The appointed officers of the Division shall be the Treasurer, the Clerk, the Directors, **the Railfest Chairman**, and the Trainwire Editor. The Superintendent shall appoint these officers.

Existing Wording

5. The Board of Directors shall consist of the two elected officers, the Treasurer, the Clerk, the Trainwire Editor, and the four Directors.

New Wording

5. The Board of Directors shall consist of the two elected officers, the Treasurer, the Clerk, the Trainwire Editor, *the Railfest Chairman*, and the four Directors.

Reason for change:

Due to the importance to the Division of Division 5's annual Railfest, it is desired to have the Railfest Chairman be a regular voting member of the Division 5 Board of Directors.

Article V. Elections

Existing Wording

5. Nominations from the Nominating Committee shall be presented at the January meeting of the election year.

New Wording

5. Nominations from the Nominating Committee shall be presented at the *first* meeting of the election year.

Reason for change:

The Division currently has our annual holiday party in January in place of our regular monthly meeting so the current Regulation wording is invalid since we do not currently have a January meeting. To provide for flexibility and reduce the need to change the Regulations in the future, the wording is being changed to present the Nominating Committee's nominations at the first membership meeting held in the election year. Article IX. Financial Procedures

Article IX. Financial Procedures

Existing Wording

1. The Fiscal year for Division 5 shall be January 1st through December 31st.

New Wording

1. The Fiscal year for Division 5 shall be January 1st through December 31st for tax purposes.

Reason for change:

Changed to add clarity as to why the Division's Fiscal year is the same as the calendar year and that, if the Division's Fiscal year is changed, our tax reporting will need to be changed.

Existing Wording

2. In October of each year, a budget for the upcoming fiscal year shall be formulated. That budget should be completed and presented to the Board for their approval at the November meeting, absent extraordinary circumstances. Upon approval it will be published in the next <u>Trainwire</u>.

New Wording

2. In October of each year, a budget for the upcoming fiscal year shall be formulated. That budget should be completed and presented to the Board for their approval at the November meeting, absent extraordinary circumstances. Upon approval it will be *presented to the membership at the next membership meeting*.

Reason for change:

To reduce the risk of outside people with malicious intents going after Division funds, Division 5 financial information is no longer published in public documents. Instead, financial information is only made available to Division members.

Existing Wording

4. The Division 5 financial books will be audited annually. The audit for the prior fiscal year is to be completed by April 1 of the current year.

New Wording

4. The Division 5 financial books will be audited annually.

Reason for change:

The audit date of the Division's financial books is not critical, only that it be done annually. Due to various timing issues and logistics, it is not always possible to perform the audit by April 1.

Existing Wording

5. A financial audit will be performed on any Division 5 event that uses a financial accounting system that is separate from the Division 5 financial books. This audit is to be performed within 90 days of the close of the event.

New Wording

5. A financial audit will be performed on any Division 5 event that uses a financial accounting system that is separate from the Division 5 financial books. This audit is to be performed within **180** days of the close of the event.

Reason for change:

Due to Railfest issues with getting final invoices in a timely manner, making final payments, and getting all accounts finalized, the existing 90 day deadline is no longer reliably achievable. The change to a 180 day deadline is more realistic and currently not a problem to achieve.

Specialty Tools Right Angle Clamps


Recently I decided to start putting some of the structures I have purchased over the past few years together. Since a lot of the structures on my layout will be repetitive, a lot of scratch building is in my future as I am basing my layout around coal mines. That means several if not more "shotgun houses" will be needed but that is down the road and winter is coming. Now, being the person or the



fool that I am I decided to start with a totally scratch built structure that I have called "The Weld Shop". The idea for this building comes from a concrete building located at the intersection of RT306 and RT6 in Kirtland. Since the build-

ing has concrete block walls, I opted to use the concrete block wall sections that Pikestuff manufactures. The two reasons (in my mind) were because the wall sections were .05 inches thick which allows for stability and are interlocking which gives it a more realistic appearance. This interlocking would become a real problem for me but nothing I couldn't overcome, more on that later as I may set up a presentation on the construction of this building. After cutting out the doors and windows and doing all the prep work it was time to put the walls together. Because of the interlocking design that walls joints become a hinge on the back side. This makes using traditional right angle gluing impossible. The joint does not allow for the use of 1-2-3 blocks, slide joint clamps or magnetic gluing tables.

So it was off to the internet and Google I went. I found some magnetic clamps from Proses call "Snap & Glue". Problem solved, no. When I went to the hobby store a pair of these clamps cost an aver-



age of \$35 to \$40. I next went to Amazon to try and get a better price. For a set of four, two solid and two adjustable, they were \$59. Well ok I can get four for less if I bought them off Amazon. So I pur-

chased a set and found out very quickly that they are manufactured in of all places, Turkey. Of course there is was charges for international shipping which raised the cost to \$63. Not much of a savings but oh well I got them and they work great. Their design allows for gluing as the center of the joint is open. A perfect fit for the Pikestuff wall I was using. I was extremely happy until I realized that it would take me a month of Sundays to construct all of the structures I planning on building. I figured that I would need at least four more sets of these clamps and at even \$35 this would not be cost effective as they would never pay for themselves. I resigned myself to spending countless hours of gluing in my future. So is the life of a modeler.

Now, don't let anyone tell you that the internet doesn't keep track of what you watch or purchase. The reason I say this is because as I went onto YouTube to watch some videos from MRBenchwork and the Crooked River & Eastern RR after I purchased the Proses clamps, what pops up but a ton of videos on right angle clamping for

modeling. Even though I had search YouTube in the past regarding this subject matter, these videos never came up. Most of them were either how to use or rating videos of the Proses clamps except for one that caught my eye. This video from "Im Being



Creative" was about how to make your own right angle clamps for modeling cheap – REALLY. The video shows how he designed and 3D printed them. The clamps are of the adjustable style but that's ok with me. I waited for the "and for a

small price you can order them" but instead he gave a Thingiverse address for a free program (STL file) download. Without even thinking I down loaded the file onto a flash drive and ran it over to a friend's house who owns a 3D printer. The file is set up for a filament style printer as there is also a resin style 3D printer for which I do not know if the file will work with it, not 3D printer savvy. My friend said to give him to the weekend to run the parts. I only asked for two sets but because he found them to be interesting he ran me seven sets. They did need a little cleaning up but nothing major, I was in heaven.

The only thing about these clamps is that they were designed by someone overseas and are

in metric measurements, ok, so what. You still need to find and purchase the rare earth magnets off of Amazon (20mm x 10mm x 2mm) and the nuts and bolts that hold the clamps together. Note – the video states that the bolts and nuts are M8 but they are actually M6 and can be purchased at a local hardware store. Now to give you guys/girls what the cost savings was, I needed 14 nuts and bolts and 28 magnets. To run the program and get seven pair of clamps it cost \$0. The nuts cost \$3.50 while

the bolts cost \$7.00. The most expensive item was the magnets which cost \$8.99 for 20; I had to buy 2 sets. That's seven clamps for \$28.50 versus the \$126.00 if ordered off of Amazon. These clamps work just as well as the Proses clamps.



If you want to get a copy of the program just Google I'm Being Creative (do not correct the spelling) and it will pop up at the top of the page. Click on it and then scroll down to the video on making your own clamps. The Thingiverse address is below the video highlighted or email me and I will bring my flash drive to one of the meetings. If you bring a flash drive we can copy it from mine to yours.

Summer Travels Part 2—Kentucky

If you didn't read part 1-Ohio it is in last months Trainwire. After Ohio I made my way down to Kentucky to visit the Kentucky Railway Museum in New Haven and ride their afternoon excursion train. This was the only item on the agenda for that day but as I pulled into my hotel that night I noticed a sign for the Louisville Antique and Toy Mall. I decided to check that out before heading to the museum the following morning. This place is a vintage toy lovers dream with 16,000 square feet and over 300 booths it really brought me back to my 80s childhood with GI Joe, Transformers, and He-Man. Sprinkled through some of the booths you could see some vintage postwar trains for sale but it was the back corner that really grabbed my attention. A vendor had turned the back corner into his own layout and train store. We talked for a bit and we ran some trains on the layout but unfortunately he didn't have anything on my list in his store.

After leaving this unplanned stop it was time to make my way over to the Kentucky Railway Museum. Now I should mention that I booked my train excursion earlier during my planning stages of this trip and I was very fortunate that I did as the museum offers one seat for sale (added cost of course) to ride in the cab with the engineer and brakeman for the duration and I was lucky enough to grab it. Included in the price of the excursion train comes admission to the museum and the museum grounds.

I started the near 95 degree day walking the grounds of the property and exploring all the various engines, passenger cars, rolling stock, and even

a turntable. Now this property is look only so you can not get on any of the equipment but you can go right up to each piece.

This is also the place where I found my first of many Merci Boxcars and was able to read about their history. The Merci Boxcars were a gift from France for the United States's help during WW2. They sent 49 of them and all the states at the time were granted one. Over time some have been lost, some are in poor shape, but some have been restored and can be viewed still today. I actually was able to see three of them throughout my travels on this trip. After spending a good hour outside exploring it was time to come inside and enjoy the air conditioned museum. It was rather small but still very informative and they had a very detailed HO operating layout inside.

Now came the time to meet my engineer and brakeman who I would be spending the next 2 hours with riding in the cab as we rode along the mountains and countryside of Kentucky. This excursion train is operated on a push pull method so the first engine I rode in was the Louisville and Nashville No. 411 which is an EMD GP7. The other was the Santa Fe 2546 which is a CF7. Of the two I much rather preferred the Santa Fe as it had a wide open view through the cab window and wasn't blocked like the 411.

The ride started out great and was picturesque for the first 45 minutes; then the weather changed. A thunderstorm rolled in and up went the windows and on came the very vintage window wipers. At one point the train had to stop as we

had debris laying across the track. Our brakeman had to climb down the engine and pull it off the track. Doesn't seem that difficult but this gentleman was 85 years old. I volunteered to do it and was actually looking forward to climbing out on the front of the engine but due to liability issues I had to stay in the cab.

At the halfway point they dropped me off on a bridge and drove the train forward so I could climb up in the cab of the Santa Fe engine for the ride back in the 2546. If you are ever driving through Kentucky I would say this museum is worth a stop and definitely if you can get it, try to book the lone cab seat.















